



### Working Capital is the life blood of any business





Asset finance refers to any physical business equipment. It is broadly split into two areas: hard asset (where there is an established and proven secondhand market for the equipment) and soft asset (there is no, or very little, secondhand market). The added security of the secondhand market means hard asset finance attracts a better rate. Our rates start at:

Hard asset: 1.45% flat rate per annum (facilities of £100k +)\* Soft asset: 2.95% flat rate per annum (facilities of £100k +)\*

\*The above represent recent transactions with profitable and established companies where the net worth of the business either matches or exceeds the value of the transaction.



Refinance

This is a working capital facility which is split in two categories:

Hard asset

Release the equity within your production line: vehicles, engineering equipment, printing press, machinery, etc. This is often more cost effective than a commercial loan. You sell title of goods to the funder, but the equipment remains insitu, the funder has equipment with good residual value which fundamentally reduces their risk, and attracts better rates for you.

Capital expenditure

Refinance recent purchases (made within the last six months) for any business asset including: signage, IT, shelving, partitioning, carpet tiles.

Development, bridging and secure lending



Vehicle finance

We can offer single car and fleet finance on lease and HP for director cars, vans, haulage and yellow goods. These attract hard asset rates starting at c 1.5% flat (£100k +). ## Commercial loans

The alternative finance market was born out of the 2008 recession. Prior to this, banks had a near monopoly on commercial loans . There is now a billion pound market offering facilities from 3 months to 5 years+ on unsecured facilities. Loans start at £5,000 with flat rates from 8% per annum. Due to the variety we would encourage you to speak with us directly so we can ascertain your needs and advise accordingly.



HMRC facilities

VAT is funded over three months with payments in arrears, and we can pay HMRC directly on your behalf. This is a fantastic working capital facility which takes away the pressure of having to bank for VAT on a quarterly basis. Interest starts from a sum total of 4.5% interest. If your VAT bill is £25,000 then you'll pay a total of £26,125 in three monthly repayments.

This corporation tax is the same as VAT, except over 12 months. Interest starts at 9.5% Per Annum so £25,000 would be a sum total of £27,877.50.

Note that we require the VAT or Corporation Tax bills as proof of loan, and the term is non-negotiable.

Both these facilities are available even if you are in arrears with HMRC, however rates may change due to underwriting and credit.
